



Privacy Policy

(August 2018)

The South London & Kent Pool Alliance, (SLKPA or the League) undertakes to protect its members' personal data and privacy, in accordance with the General Data Protection Regulations, (GDPR) 2018, which require that personal data must be:

- Used lawfully, fairly and in a transparent way.
- Collected only for valid purposes, that may include providing contact details, personal information, and official documentation to governing bodies or individuals to ensure the efficient organisation of the League and its associated competitions.
- Supplied relevant to the purposes of the SLKPA, to act on behalf of its members.
- Kept secure and confidential.
- Kept only for as long as necessary, for the SLKPA to discharge its responsibilities, with regard to handling the interests of its members, both current and past.

The personal data of SLKPA members is required in order for the League to operate effectively and efficiently. As a membership-based organisation, the SLKPA may keep a record of its members':

- Names
- Addresses (both postal & email)
- Phone numbers
- Bank details
- Photographs & videos
- Dates of birth (for minors only)

Our members have the right at any time to the deletion of their personal data and to withdraw consent for its use. Personal data will be deleted within two years of the member ceasing to be a member of the League or within one month of consent being withdrawn. Some personal data of former members may be retained for financial reasons only. Members and former members may, at any time, request a copy of all information about them that the League hold, and to have that information corrected.

The SLKPA will collect only the personal data that is needed for the effective and efficient organisation of the League and its associated competitions. This may include the passing of personal data to governing bodies such as; the English Pool Association, (EPA) or the Greater London County Pool Association, (GLCPA), but only if relevant. Personal data will not be supplied to third parties not connected to the League or the sport of pool without the prior consent and permission of the member(s) concerned.
